

# Preparing Guidelines for Houses for Child Rearing

## 1. Introduction

In the Basic Housing Plan (Nationwide), approved by the Cabinet on March 28, 2016, “Realizing a housing environment where the young generation or child-rearing families who wish to marry and have children feel assured” was stipulated as Target 1. In an interim report of the safe housing policy research conducted by the Ministry of Land, Infrastructure, Transport and Tourism (MLIT), published on April 17, 2015, “Setting a guideline for the promotion and diffusion of houses where people can feel assured and raise children” was designated as one of the priority measures that should be taken.

In response, research was conducted to identify what should be taken into consideration when designing a house that should be suitable for child rearing (hereinafter called the “houses for child rearing”) in FY2016. The levels of the privately designed houses for child rearing and consumer needs for such houses were investigated. Based on the result and from the standpoint of technical and social validity, draft guidelines for the houses for child rearing were prepared.

## 2. Outline of the Draft Guidelines for Houses for Child Rearing

As shown in Table 1, 50 items that need to be taken into consideration are extracted and categorized from four points of view in the draft guidelines. For each item, the necessity, the age of the child who needs the arrangement (categorized into infant, early or late childhood, children in early or late elementary school years and junior high school student), and concrete ideas of improvement and its level are stipulated (Table 2).

The types of the dwelling (owned house, owned apartment house, or rented apartment house), newly built or existing, and the degree of the importance of the item (essential or preferable) are also clearly specified.

## 3. Reflection of Future Achievement

Guidelines are to be drawn up based on this proposal and planned to be published by the Housing Bureau. A new support system for the houses for child rearing will be established based on the guidelines.

Table 2: Sample of the Items with Concrete Information  
(summary)

(1) Prevention of accidents by collision

Necessity	- There is a risk of an accident because infants walking while holding on to something and children running around may collide against walls, pillars, and furniture.
Age	Infant and early and late childhood
Concrete improvement	i) Chamfer the outside corner of a wall, pillar and built-in furniture. ii) Consider the arrangement of rooms to avoid making an outside corner of a wall. iii) Use sliding doors. Use a door stop for a hinged door. iv) Use an alcove in front of a shared corridor to avoid a front door from protruding into a corridor.
